

TERMS AND CONDITIONS (T & Cs)

Please read these carefully and ensure your entry complies with them.

COMPETITION TERM AND CONDITION SUMMARY

1. By submitting a photograph you are agreeing to our terms and conditions and you are consenting to the possible use of that photograph on website or social media hosted by The Moving on Project in relation to this competition. Any photographs used will be credited to the photographer. ***If you are under the age of 16 you must have permission to enter from your parent or guardian.*** By submitting an entry for the competition, your parent or guardian is deemed to have given such consent and to agree to the use of the entry as described in these terms and conditions. 2. All images will be moderated by a panel of selectors before they are added to an online gallery of competition entries.
3. Only images taken by 11-17 year olds who live in Hampshire, UK will be included.
4. Offensive material will not be included.
5. You must own the copyright of any images you submit so please do not upload other people's work.
6. Closing date for entries is 5pm 11th June 2021
7. The Winner will be notified by The Moving on Project by 30th July 2021, details of which will be sent by email.
8. In order for photographs to be considered for inclusion in 'Mental Health and Me' Project exhibition they will need to be printable.
9. Please include your full name, age and telephone number/s.
10. Only ONE image per person can be entered.

- These terms and conditions govern the 'Mental Health and me' Photographic Competition 2021, which is organised by The Moving On Project.(TMOP).
- The competition opens on 4th May 2021 and closes on 11th June 2021.
- ***It is the Entrant's responsibility to have read the TMOP T&Cs prior to or at the time of entry into the Competition, and entry into the Competition will be treated as acceptance of these TMOP T&Cs.***
- Any entry found not to comply with the competition rules is liable to be disqualified.
- The organisers reserve the right to refuse any entry to the competition for any reason.
- TMOP reserve the right to modify these terms and conditions without notice.

CONDITIONS OF ENTRY

- By submitting pictures, you are confirming you took them yourself and that you own all the copyright and other rights connected with the photograph and that there will be no fees attached to TMOP using the pictures in any way.
- The photographs will be judged against the following brief: ***Produce an image that suitably represents 'Mental Health and Me'***

- Photo entries will be judged based on creativity, quality, originality, responsiveness to the theme and overall impact.
- You may submit one photograph. These can be colour or in black and white.
- **Any images that may cause offence or are considered inappropriate will be disqualified.**
- There are no restrictions on the type of camera used. The original file should be as large as you can achieve with your equipment.
- People submitting photographs to TMOP retain the right to use those photographs again themselves for personal and/or commercial purposes.
- TMOP will not necessarily keep copies of all pictures submitted to the competition, so entrants should keep a copy of any pictures they submit themselves.
- TMOP is not responsible for any loss or damage to any photograph that may occur as a result of them being entered for the competition and shall not be held responsible for technical errors in telecommunication networks, preventing entry to the competition.

ENTRY DEADLINE:

- All entries must be received by the advertised closing time & date 5pm GMT on 11th June 2021.
- Late entries will not be accepted. No responsibility can be accepted for lost entries and proof of transmission will not be accepted as proof of receipt.

HOW TO ENTER:

- Entries must be submitted digitally via the email: photocomp@the-mop.org
- A picture is considered submitted for the competition if it is sent to the TMOP email.
- Please include details of where and when each image was taken, and your contact information, including a name, postal address and telephone number.
- A caption must be submitted with every Entry into the Competition. Captions must include background information about the Entry, such as any motivations & special circumstances surrounding the Image. **Failure to submit a caption may result in the Entry's disqualification.**
- Captions must also include what photographic equipment was used as well as the camera settings that were used.
- All content within the Caption must be truthful, complete & accurate, & must not mislead or omit details that may later be detrimental to the judging process.
- It is the entrant's responsibility to ensure that all necessary permissions are obtained. You must complete an entry form. If a selected person photograph contains an image of a minor (person under the age of 16) then photographers will be required to submit a **participant release form** signed by the parent or legal guardian of the minor.
- If the entrant is unable to provide all required releases, TMOP in its sole discretion reserves the right to disqualify the submission, seek to secure the required releases, or permit the submission to remain in the contest.
- We will not return any images submitted for the competition, **so please make a copy.**
- Photos that violate or infringe upon another person's rights, including but not limited to copyright, are not eligible.

REGISTRATION AND FILE UPLOAD SPECIFICATIONS

- Photographs must be submitted in .jpeg format

- To ensure that the image is of the best quality we recommend saving the file as 72 PPI.
- Mobile photographs are exempt from this size requirement, but must be submitted at their highest resolution upon request. The file must not be larger than 15MB
- TMOP reserves the right to disqualify incomplete entries and/or contestants who are unable to submit, upon request, a high-resolution photograph.
- Please keep copies of all your original and resized images safe. |

IMAGE MANIPULATION AND AUTHENTICITY ASSURANCE

- All Images must be a complete record of all that was in the Image at the time it was taken.
- The judges reserve the right to exclude any image they believe may have been excessively treated so as to alter its authenticity.

ETHICAL REQUIREMENTS

- All Entrants must ensure their submissions have been ethically obtained.
- If TMOP or the judges suspect that a picture was taken using unethical practices, the entry will be disqualified.

JUDGING & PRIZES

- The judging is performed by a panel of independent judges, selected & appointed by TMOP.
- TMOP and the Judge's decisions are final, and no correspondence will be entered into concerning the competition's judging and organisation.
- The winner will be notified within three weeks of the closing date of the competition.
- TMOP will notify winners via the contact information provided at the time of entry; TMOP may disqualify anyone who fails to respond to the notification within five business days.
- Please do not contact us about the status of entries or judging.
- Judging will be anonymous. Judges will assess entries against the brief.
- The Entrant gives permission for the TMOP to send the copyright owner's Entry (image files and Captions) to the Competition's Judges, to facilitate the judging process.
- Judges are provided with guidelines for procedures relating to the process, the judging and any conflicts of interest.
- One prize will be awarded. The winner will receive £250
- All images may be featured by TMOP
- The winners will be contacted using the contact details provided by telephone or email.
- If TMOP is unable to contact winners after reasonable attempts, they reserve the right to offer the prize to a runner-up.
- Those shortlisted will need to provide proof of age.

COPYRIGHT AND REPRODUCTION

- The contestant certifies that they are the sole creator, copyright owner and any other intellectual property rights of each submitted image.
- The owner of the copyright agrees to grant TMOP a non-exclusive Licence (the "Licence") to reproduce, publish and exhibit the copyright owner's Images upon entering the Competition.
- You retain your copyrights to your photograph; however, by entering the contest, you grant TMOP (and those authorised by TMOP) a royalty-free, world-wide, perpetual, non-exclusive license to publicly display, distribute, reproduce and create derivative works of the entries, in whole or in part, in any media now existing or later developed, for any purpose, including, but

not limited to, advertising and promotion on its website, exhibition, and commercial products, including but not limited to TMOP publications.

- Any photograph reproduced will include a photographer credit as feasible. While we make every effort to credit photographers, including in printed reproductions of their work, we cannot guarantee this.
- They also agree to take part in post-competition publicity. No fees will be payable for any of the above uses. Media will be allowed to publish winning images free of charge for the purpose of promoting the photography competition without express permission from the photographer.

DATA PROTECTION

- All personal data, collected by the Admin will be managed & protected in accordance to the Data Protection Acts of 1998 & 2018.
- The Entrant's contact email addresses & name data will be stored and added to a mailing list that will solely involve the Competition itself and event activity.
- Entrants may contact the Admin at any time to delete or update that Entrant's details on the Admin's record using photo.competition@the-mop.org.
- In accordance with the GDPR and Data Protection Bill. TMOP will hold all personal data securely. It will only be used in the process of administering the Photography Competition in the exercise of the TMOPs official authority and public task, and will not be transferred to any third party.

DISCLAIMER & DISQUALIFICATIONS

- TMOP is not responsible for incomplete or misdirected entries, technical or network malfunctions or failures, or causes beyond their control.
- Entrants are solely responsible for their entries. Entrants may not submit materials that introduce any software viruses, worms or other programs designed to damage software, hardware or telecommunications equipment or are off-topic, contain advertising, personal attacks, or is otherwise abusive, threatening, unlawful, harassing, discriminatory, libelous, obscene, false, sexually explicit, or that infringes on the rights of any third party.
- The Entrant agrees and undertakes not to use any names, logos or any other intellectual property, or to make any public statement, in each case regarding either TMOP or the Competition, without gaining prior written consent from the TMOP
